They are also stated to be better suited for the present requirements of society and national security. New criminal laws aim to consolidate the traditional provisions and procedures, making them more concise, contemporary, and relevant. The Bharatiya Nyaya Sanhita, specifically addressing organised crime, represents a significant shift in the legal landscape in India, with immense potential to empower a forensic investigation process. First information reports (FIRs) can now be filed online through the Crime and Criminal Tracking Network Systems (CCTNS), allowing e-FIRs and zero FIRs in multiple languages without needing to visit a police station. Central Government is taking significant steps for enhancing law & order in the country and now its time for state governments to take immediate actions and make sure to increase social welfare in all urban and rural areas, justice for all citizens in every city, state. Pushing collaboration between law enforcement agencies, forensic experts, e-courts, and technology companies can facilitate information sharing, knowledge exchange, and the development of innovative solutions to help secure digital evidence. There are incidents recently noticed in India & several countries, government ministry heads, police officials, government embassies officials personal data, personal mobile, email, computer system are hacked & threatened using different electronic modes. Several companies witnessed scam, fraud, hacked mobile (complete tracking of different communication applications, phone calls, sms), email, other electronic devices, government organisations also experienced similar issue. In India some people looted common citizens being fake police officer, fake income tax official, fake cbi officer & asked to deposit money using name of government officials from police, income tax department, threatening for digital arrest. New criminal laws will surely help citizens & police department officials to reduce overall crime rate. Ministry of Electronics need to also gear up for advancement in technology & safeguard common citizens from digital money frauds, fake digital arrest otherwise common citizens will die without any reason. Dark Web is reality and mobile phones whether it runs on Android or iOS are getting hacked, police officials now need to gear up for same.
